Individual Membership: Membership in the Southwest Indian Agricultural Association is open to any American Indian person with an interest in the management and development of American Indian agriculture resources and agribusinesses. **Membership and voting rights become effective with payment of annual dues.**

American Indian Organization Membership: Membership in the Southwest Indian Agricultural Association is open to any Indian organization recognized by its Tribal Government and/or a federally recognized Tribe with an interest in the management and development of Indian Agricultural resources. **Voting rights for voting delegate become effective with payment of annual dues.**

Associate Membership: Any Individual who has an interest in the management and development of American Indian agricultural resources may apply for Associate Membership. **Membership becomes effective with payment of annual dues.**

Corporate Membership: Any Corporation supporting the purpose of the Southwest Indian Agricultural Association may apply for Corporate Membership. **Membership becomes effective with payment of annual dues.**
